



Salon Pro Deluxe Hire Terms and Conditions;

1. Pricing

- 1.1 The price quoted includes VAT (unless otherwise stated). VAT will be charged at the rate applying at the time of delivery.
- 1.2 Our quotations lapse after 21 days (unless otherwise agreed in writing).
- 1.2.1 Prices are subject to change without notice.
- 1.3 The total price quoted will comprise a hire charge per week/month for the equipment supplied and a delivery/installation charge (unless otherwise agreed).

2. Delivery

- 2.1 Quoted delivery dates are estimated only and as such are to be used for guidance only.
- 2.2 Whilst every reasonable effort shall be made to keep to any delivery date, InternetshopUk.Com Limited shall not be liable for any losses, costs, damages, or expenses incurred by the customer or any other person or company arising directly or indirectly out of any failure to meet any estimated delivery date.
InternetshopUk.Com Limited shall not be liable for any non delivery of goods. Any liability shall be limited to redelivery of the goods within a reasonable time.
- 2.2.1 Cancellations shall not be accepted once goods have been dispatched.
- 2.2.2. We may decline delivery if we believe
 - It would be unsafe, unlawful or unreasonably difficult to do so
 - Access to the delivery premise is unsuitable for the delivery vehicle
- 2.2.3. Should delivery be unreasonably refused by the Hirer, we reserve the right to charge a fee for storage and or redelivery, however at our discretion we may consider this to be a breach of contract on your part and as such cancel the contract with no further liability.
- 2.2.4 You must inspect goods on delivery and notify us of any damages immediately, failure to do so will void your contract as products will be deemed to have been delivered in good, working and saleable condition.

3. Payment Terms

- 3.1 **You are bound contractually by the terms of this contract once your payment has been received.**
- 3.2 **You will initially pay for the first 4 weeks rental period and a delivery/installation charge. Subsequent rental will be charged every 4 weeks to your credit card until you give us 7 days notice in writing prior to the agreed hire term expiring.**
- 3.3 Where payment is by bank transfer, cheque or other cash means, all monies must be cleared by our bank pre delivery.
- 3.4 You do not have the right to offset any money you may be owed by us or in the process of claiming from us, against any monies owed to us by you.
- 3.5 We reserve the right to collect any property owned by InternetshopUk.com Limited, that maybe in your possession at any point, whilst any outstanding amounts in relation to your account remain unpaid.

4. Ownership and Risk

- 4.1 The risk in goods damage shall pass from Internetshopuk.Com Limited to the hirer on delivery of the goods to the hirer, under the terms of this contract the product still remains the property of Internetshopuk.Com Limited during the hire period, however any damages incurred during the hire period are the sole responsibility of the hirer and as such Internetshopuk.Com Limited

reserve the right to bill any charge for damage or repairs to the hirer and recollect the item hired, without issuing any refund for any period of the hire period not undertaken at the time of damage.

- 4.2 Should the equipment be returned in a poor, damaged or non working condition, at the end of the hire period, you will be billed for the total cost of all repairs. Should the product be deemed Non repairable, you will be invoiced for the full cost of a replacement product.

5. Return of Goods

- 5.1 We will accept returned goods only direct from the hirer, no third party agreements will be entered into.

- 5.2 We reserve the right to charge the full hire fee on products which have been reported and returned as faulty but are deemed fit for purpose on their return.

- 5.3 Goods that have been subjected to misuse and or used inappropriately, that are not deemed to have a manufacture fault on their return, will under no circumstances be refunded for any part of the hire period.

6. General

- 6.1 English Law is applicable to any contract made under these terms.

- 6.2 All members, Trustees and or Directors of the company have equal obligation under these terms.

- 6.3 Hirers can at any time be requested to return any products direct to us, within a given timescale. This would only be for financial reasons that could cause the company to cease trading if this were not undertaken. At this point all accounts would be suspended and hirers notified of our position.

- 6.4 **HIRERS ARE STRICTLY PROHIBITED FROM SUPPLYING TO THIRD PARTIES.**

- 6.5 **THE HIRED PRODUCT MUST REMAIN AT THE ADDRESS IT WAS DELIVERED TO AT ALL TIMES, AND BY NOT COMPLYING WITH THIS CLAUSE YOU WOULD INVALIDATE ANY CONTRACT ENTERED INTO.**

- 6.6 **YOU ARE NOT OUR AGENT AND HAVE NO AUTHORITY TO MAKE CONTACT WITH ANY OTHER PERSON OR COMPANY ON OUR BEHALF OR IN OUR NAME.**

- 6.7 **YOU ARE NOT PERMITTED TO USE ANY INTERNETSHOPUK.COM LIMITED LOGO OR TRADE MARKS ASSOCIATED WITH OUR PRODUCTS WITHOUT OUR EXPRESS WRITTEN PERMISSION TO DO SO.**

- 6.8 **SHOULD INTERNETSHOPUK.COM LIMITED HAVE ANY REASON TO BELIEVE THAT THE TERMS AND CONDITIONS CONTAINED HEREIN HAVE NOT BEEN ADHERED TO IN ANY FORM, WE RESERVE THE RIGHT TO COLLECT ANY PRODUCT PREVIOUSLY DEEMED AS HIRED.**
